MALAYSIA MY SECOND HOME PROGRAM (MM2H)

The Malaysia My Second Home (MM2H) Program is a government-endorsed initiative that allows qualified foreign nationals to reside in Malaysia on a long-term basis. The following outlines the package criteria, participation requirements, and necessary documentation for application.
